II.	Acceptance of Agenda- motion Kelsi / Angie
III.	Acceptance of Aug 15 th , 2022 Minutes, Fr. Keith made correction on 8/15/2022 minutes that it was Fr. Keith, not Fr. Kevin that gave the presentation regarding the updated tuition chart noted in the VI section of financial report. They were then approved.

V.	Superintendent Report – Geoff Andrews
	 A. Advancement/Marketing Director for St. Mary's/Sacred Heart. Tossed around this idea to give us more of a presence in the community. Geoff will draft and email job description. Very important to have a strong job description. Mr. Bonilla running it by the GS council. Fr. Kevin said that in the past, people we hired for positions, with no strong job description, floundered. Without strong direction from the job description, the person was easily moved off the task they were hired for. B. Geoff is starting Mondays at SHHS greeting students. Working on them making eye contact and greeting him back. C. ARK assessment of religious knowledge. Will be given grades 2-12 will be given. Chancery will pay for this. D. SGO final applicants 80 new K-8 throughout diocese, last year 171K this year 170K E. KSHSAA vote for multiplier is next week. F. The has been a Joint leadership team administration team started with Superintendent Geoff Andrews and both principals and vice principals of GS and HS as members.
VI.	Financial Report- Mr. Krajicek/Mrs. DelReal
	A. Tuition. There are a couple of discrepancies in the current tuition chart that need to be
	addressed. Current bracket has had a ½% increase and an additional income bracket added each year for the past three years.
	B. The Finance Council, led by Fr. Keith Weber presented 3 formulas for proposed tuition:
	Current Tuition where the lower income families were paying much tuition but a higher

percent of their income than those in higher income brackets; and 2 New proposals which include Option A and Option B. These were presented at the August COE meeting, and members were to review and come back this month to give Finance Council guidance and recommendations. Fr. Keith again reviewed the formula charts. In Option A, the higher incomes pay higher percentage of income, percentage decreases as income decreases. Option B, all incomes pay same percentage of income for tuition. Discussion ensued by all present, and one member who could not be present for the discussion had emailed thoughts and vote. At the end of the discussion, all, less one, thought option A was the best option and sent as the recommendation to be returned to Finance council for further review. A motion made by Colleen/Kelsi to add 3 income lines and adopt A with the 3 income bracket additions and all agreed less one. The person dissenting wanted only one bracket line added and wanted option B adopted.

- C. Discussion about, on option A, to increase proposed % of income from 5.5 to 6.0 (currently paying 6.5) so it would still help the lower income families. Motion made by Kelsi to adopt option A and move families making 45K and below to 6.0% on the proposal A instead of 5.5% as currently listed. Yoena seconded. All present approved.
- D. Non Catholic families' options discussed- Add 1% to whatever a Catholic is paying OR non Catholic jump up one bracket. Consensus was to put them in the next upper bracket. Motion by Greg /Kelsi to move up a bracket and all present agreed. And pay one bracket. We have 20-25 non-Catholic students, about 10-12 families.
- E. These have not been consistent over the years. This formula makes it even.
